The contest ends at September 1, 2017, midnight CET. Entries received after this date and time will not be considered.

Prizes

The 12 winners will get a Leo package which includes amongst other things a Leo toy, book, and growth chart. Phonak will cover shipping and handling cost.

Winner selection
